Who We Are

The Minnesota Board of Legal Certification authorizes legal agencies to certify Minnesota lawyers as specialists in defined fields of law. The Board's purpose is to provide the public with enhanced information about lawyers who specialize in one or more fields of law. The Board seeks to ensure that lawyers identifying themselves as "specialists" have the appropriate knowledge and expertise associated with the specialist designation.

To become accredited an agency must complete an application and provide necessary documentation verifying that the agency:

- Has personnel or Board members with expertise in the field of law
- Makes the certification available to lawyers without discrimination
- Agrees to publicize the program in Minnesota
- · Agrees to comply with the regulatory Rules in Minnesota
- Agrees to keep statistics and report on an annual basis
- Agrees to provide notice to certified specialists of advertising requirements in Minnesota

The Board reviews each agency's standards and examinations at least once every three years. Members of the Certification Board are appointed by the Minnesota Supreme Court for three year terms.

New agency application:

In 2018, the Board received a new application for accreditation from the International Association of Privacy Professionals (IAPP) to certify lawyers in the specialty field of Privacy Law. The Board is in the process of reviewing the application.

In November of 2018, the Board advised the American Board of Certification that the Board would be rescinding its certification for failure to comply with Rule 116, which requires that an agency submit an application for recertification every three years. The agency appealed and the matter was pending at the end of 2018.

The Board also advised the National Board of Trial and Advocacy, that it was rescinding its certification for failure to comply with 116(a)(3), which requires agencies to provide copies of the most recent examination administered since the last renewal of accreditation. The agency complied with this obligation following receipt of the Board's determination and we anticipate this will resolve in 2019.

Certified Specialists

Each year, certifying agencies submit annual reports to the Board showing the number of Minnesota lawyers certified, recertified, and decertified, as well as how many new lawyers have applied for their programs. The chart below shows the number of certified specialists over the last several years. There continues to be a decrease in the number of certified specialists. Agencies have noted that many lawyers are retiring, while lawyers indicate it is harder to obtain certification due to some of the practice requirements. The Board has discussed ways to encourage promotion of certification in Minnesota and routinely asks agencies for additional information on how the agency promotes certification.

The Certification Board is self-funded through certified lawyers and certifying agency fees. Fees collected include:

• Agency application fees: \$1,000

• Agency annual fees: \$250 per specialty field

• Lawyer annual fee: \$45

• Initial lawyer certification fee: \$100

The Board has a cash-carry-forward fund balance that is close to its annual expenses, and is in stable financial condition.

Board Members and Staff

The Supreme Court Appoints twelve (12) members to serve on the Board, nine (9) of whom have active licenses to practice law in the state and three (3) who are public members. The Minnesota State Bar Association nominates three of the attorney members. The court designates one member to serve as Chair. No member may serve more than two, three-year terms except for the Chair, who may be appointed for longer
